3.	Derbyshire Local Offer Steering Group Action Tracker

	Action : Publication of parent friendly 'Inclusion Framework Statement Publication'. Chair explains the new framework has not yet been released to the service. Select steering group members are to meet on the 21st of July 2025. Chair requested visibility of DPCV representative email addressed to enable sharing of invites.

	Action : Set-up an 'External Provider Onboarding Approval Subgroup'. It is proposed to meet in early August. LO Admin and Chair will invite attendees who registered interest.

Minutes: Item No: **Local Offer Introductory Video Update** LO Admin delivered an update as requested by 'Participation and Children's Rights': "We are pleased to confirm the short video, created following the sessions with young people at Ashgate Croft School earlier this year, is being finalised and almost ready for premiere. The logos are being updated to higher quality versions, and credits being finalised. Before it is shared more widely or published, the video will be premiered at Ashgate Croft School, with a date still to be confirmed. It was suggested as a classroom screening, or part of a school assembly, whichever they felt most appropriate. Once the video has been premiered, it will be made available to all other schools as part of a larger task to request schools update the information published on their website relating to the Local Offer. We anticipate the full launch to coincide with the 2025/2026 academic year. We are especially keen to ensure that any young people who are due to leave Ashgate Croft this summer, have the chance to celebrate their contributions and share the final edit with their peers, staff, and families." **Local Offer Publishing Resource Pack (from Comms Action Plan)** This document is a first initial draft of the Derbyshire Local Offer publishing pack. Please consider reviewing the document and make suggestions for changes if you would like. We have already received some very complimentary comments, and some requests for amendments which have been captured and actioned. **Derbyshire Local Offer Steering Group Teams Channel** A 'Microsoft Teams' channel has been created for the Derbyshire Local Offer steering group attendees to collate resources, information and streamline our communications. LO Admin will soon be migrating resources into it. The Teams channel value will organically grow over time. Regular attendees will soon receive invites to be added to this Teams Channel. If you would like to delegate access to other contacts, please inform Local Offer Admin who will action the addition. We aim to have everyone added to the Teams site by 27 June 2025. If you have not been invited or cannot see the Teams site in the Teams application, please inform Local Offer Admin. Preparing for Adulthood (PFA) Lead - To complete the actions relating to PFA, we are working in a 8a. 'PFA Champions Group' within 'Inclusion Support Advisory Service (ISAS)'. We are also linking in with some of our special schools; one of which is Ashgate Croft. We also link in with the Ordinarily Available (OA) workstream to prevent work duplication. PFA suggests that Participation and Children's Rights should collaborate to look at the PFA section. The PFA lead is the link officer for Ashgate Croft School, who is also working with Brackenfield Special School. The PFA Champions Group are working with parents and carers, asking what topics of advice they would like resources publishing for. We would like to publish a guide on supported internships. LO Admin will soon be contacted to begin updating the PFA content on the website.

Public Item No: Minutes: 8b. **DPCV Representative (1):** Parents have told us it isn't useable. That it is difficult to navigate. What can be changed? We have been told it is also not accessible. LO Admin explains the website fully meets WCAG A and AA standards, and is 99% compliant with AAA, which is not currently enforced. LO Admin have attended public forums to acquire feedback. While feedback from parent carers suggests some do and don't like the design and features, the feedback often lacks detail, meaning it is difficult to identify changes needed to be made. We have received only 5 pieces of feedback within 2025. Co-production stakeholders chose the current design. **Chair** requested the creation of a questionnaire to provide to DPCV to use during public forums. **DIASS Representative (1)** explains feedback from public suggests they find it difficult to navigate and stated the website is text-heavy. DIASS representative asked that LO Admin please consider the questions carefully and make it appropriate for people with learning difficulties or disabilities. NHS Representative (1) stated it is difficult to meet every person's unique specific requirements and suggested an easy read version of the website, or images be implemented to alleviate difficulties experienced by those who may struggle with reading. NHS Representative (2) stated a review of SEND Self-Assessment of the NHS trust has been completed and that responses received relating to the LO Website are negative. The self-assessment identified that some NHS staff don't want to recommend the LO website as parents and carers provide negative feedback. Some features of the website are brilliant, for example, 'Read Aloud', but I question that users know how to use this. Colour contrasts also make it difficult for some to read. **LO Admin** requested specific information to enable actions to be taken to make improvements. NHS Representative (2) responded to state the website needs more images, it isn't very engaging, but I will explore the feedback provided by staff during the SEND Self-Assessment. Social Worker (1) stated that a collection of documents and resources will be shared with LO Admin, alongside the listing of the following suggested improvements: Add feedback form to homepage Add easy-read alternatives Add videos to pages linking to YouTube videos that explain the webpage content Add screenshots and videos Add a guide for how to access device accessibility features **DPCV Representative (1)** requested that we ensure any activity is completed in co-production. **DIASS Representative (1)** suggested a different style of consulting where questions are laid out, or maybe a presentation, receive feedback on the questions and answers, be a little more lateral.
